

Dear Colleagues in Ministry,

The Commission for Nurture and Outreach of The Presbytery of Scioto Valley (PSV) seeks to be a resource to assist congregations to be missional churches within the Presbyterian Church (USA). This partnership includes the Session-endorsed Neighborhood Mission Grant program which *seeks to honor the way your congregation reaches out in the name of Jesus Christ to your neighboring surroundings at this time.*

The Commission's criteria for these Neighborhood Mission Grants are:

- The mission project is financially supported by the congregation and is evaluated and endorsed by the Session.
- Only one project per church will be considered for mission grants.
- Funding priority will be given to churches submitting requests for first-time projects. Second consideration will be giving to recurring projects that add significantly new dimensions of service. *If the request seeks funding for a project without significant revision, such projects may not receive immediate funding, but depending on available funding, may be considered at a later date in the calendar year.*
- The project involves members of the congregation in “hands-on” ministry and builds the relationship between the congregation and the community.
- The project is consistent with our Christian faith and is compatible with the mission of the Presbytery of Scioto Valley.
- Grants may not normally be used for construction, capital improvements, or furnishings.
- Grant requests may not exceed \$3,000.

The Commission for Nurture and Outreach is concerned that mission dollars be used in effective, life-affirming ways, which allow people to maintain dignity, to act on their own behalf, and to be partners in activities that affect their lives. We encourage your planning team or committee to take some time to view this conversation with Robert Lupton, and others given to the Columbus Metropolitan Club at <https://www.youtube.com/watch?v=ssuMALbhnwA> then share how your plan relates to the “Oath for Compassionate Service” that Lupton describes. The oath is as follows:

- Never do for the poor what they have (or could have) the capacity to do for themselves.
- Limit one-way giving to emergency situations.
- Strive to empower the poor through employment, lending and investing, using grants sparingly to reinforce achievements.
- Subordinate self-interests to the needs of those being served.
- Listen closely to those you seek to help, especially to what is not being said—unspoken feelings may contain essential clues to effective service.
- Above all, do no harm.

An application for funding follows and can be submitted at any time throughout the year. Applicants will be notified of Commission's decisions contingent upon available funds. **Applications are typically reviewed at CNO's monthly meeting, and, if approved, funding is typically distributed within a month of approval.**

We urge your congregation and all the churches of our Presbytery to increase pledges to the Basic Mission budget of our denomination. This funding is the source for our mission budget within the Presbytery, including Neighborhood Mission Grants. Your response determines how well we can provide partnership assistance for your mission outreach.
